<b>ALABAMA</b>	Consumer Permit	No limit. Consumer must obtain permit in advance and wine can only be shipped to state store. Copy of permit must accompany shipment.		
<b>ALASKA</b>	Direct	A reasonable quantity.	No limit.	
<b>ARIZONA</b>	Permit	1/1/17 - 12/31/17: Limit is 6 (54 liters) cases of wine per consumer in per calendar year 1/1/18 - 12/31/18: Limit is 9 (81 liters) cases of wine per consumer per calendar year 1/1/19 beyond: Limit is 12 (108 liters) cases of wine per consumer per calendar year		
<b>CALIFORNIA</b>	Direct	No limit.	No limit.	
<b>COLORADO</b>	Permit	No limit.		
<b>CONNECTICUT</b>	Permit	Limit of 5 gallons per consumer per address in any 60 day period.		
<b>DELAWARE</b>				On-site purchase only with no limit.
<b>D.C.</b>	Direct	Limit of 1 case per consumer per address per month.		
<b>FLORIDA</b>	Direct	No limit.	No limit.	
<b>GEORGIA</b>	Permit	Limit is 12 cases per address per calendar year.		On-site purchase only with a limit of 5 cases per consumer per calendar year.
<b>HAWAII</b>	Permit	Limit is 6 cases (9 liters per case) per address per calendar year.		
<b>IDAHO</b>	Direct	Limit is 2 cases (9 liters per case) per consumer per address per shipment.	Limit is 2 cases (9 liters per case) per consumer per address per shipment.	
	Permit	Limit is 24 cases per consumer per calendar year.		
<b>ILLINOIS</b>	Permit	Limit is 12 cases (9 liters per case) per consumer per address per calendar year.		
<b>INDIANA</b>	Permit	Limit is 24 cases per consumer per address per calendar year. The permit holder has no knowledge that consumer has received in excess of 24 cases; and at the time of transaction, the consumer represents that sale will not result in them receiving in excess of 24 cases in the calendar year. Winery can ship 3,000 cases total into the state per year.		
<b>IOWA</b>	Permit	No limit.		
<b>KANSAS</b>	Direct	Limit is 12 cases per consumer per address per calendar year.		On-site purchase only. No limit.



## Quantity Limits by State

LOUISIANA	Permit	Limit is 12 cases per consumer per address per calendar year.		
MAINE	Permit	Limit is 12 cases per address per calendar year. No containers smaller than 750ml may be shipped; containers of 750ml or larger are permitted as long as a case holds no more than 9 liters.		
MARYLAND	Permit	Limit is 18 9-liter cases per address per calendar year.		
MASSACHUSETTS	Permit	Limit is 12 9-liter cases per consumer per address per year.		
MICHIGAN	Permit	Limit is 1,500 cases total per winery per calendar year.		
MINNESOTA	Direct	Limit is 2 cases (9 liters per case) per consumer per address per calendar year.		
MISSOURI	Direct	Limit is 2 cases (9 liters per case) per consumer per address per calendar year.		
	Permit	Limit is 2 cases (9 liters per case) per consumer per address per month.		
MONTANA	Permit	Limit is 18 cases (9 liters per case) per consumer per address per license year (Oct 1-Sep 30).		
NEBRASKA	Permit	Limit is 1 case (9 liters per case) per consumer per address per month.		
NEVADA	Permit	Limit is 12 cases per address per fiscal year.	Limit is 12 cases per address per fiscal year.	
NEW HAMPSHIRE	Permit	Limit is 12 cases (9 liters per case) or equivalent (108 liters) per consumer per address per calendar year.		
NEW JERSEY	Permit	Limit is 12 cases (9 liters per case) per consumer per address per year for wineries producing less than 250K gallons annually.	No limit.	
NEW MEXICO	Permit or Direct	Limit is 2 cases (9 liters per case) per consumer per address per month.	Limit is 2 cases (9 liters per case) per consumer per address per month.	
NEW YORK	Permit	Limit of 36 cases (9 liters per case max) per consumer per address per calendar year.		
NORTH CAROLINA	Permit	Limit is 2 cases per consumer per address per month. Once a winery ships 1,000 cases into NC, it must get a NC wholesaler and sell 3-Tier if any distributor is interested.		



## Quantity Limits by State

<b>NORTH DAKOTA</b>	Permit	Limit of 3 cases (27 liters) per consumer per address per month.		
<b>PENNSYLVANIA</b>	Permit	Limit of 36 (standard 9 liter) cases per consumer per address per calendar year.		
<b>OHIO</b>	Permit	Limit based on "Family Household", is 24 cases from all wineries per address per calendar year. Violation of the case limit falls solely to the consumers who order the wine.		
<b>OKLAHOMA</b>				On-site purchase only with a limit of up to 1 liter per purchase.
<b>OREGON</b>	Permit	Limit is 2 cases (9 liters per case) per consumer per address per month.		
<b>RHODE ISLAND</b>				On-site purchase only. A reasonable quantity.
<b>SOUTH CAROLINA</b>	Permit	Limit is 2 cases per consumer per address per month.		
<b>SOUTH DAKOTA</b>	Permit	Limit is 12 cases (9 liters) per consumer per address per calendar year.		
<b>TENNESSEE</b>	Permit	Limit is 9 liters per consumer per address per month and a maximum of 27 liters per calendar year.		
<b>TEXAS</b>	Permit	Limit is 9 gallons per consumer per address per month. Limit is 36 gallons per consumer per address per calendar year. Limit is 35,000 gallons per winery per year.		
<b>VERMONT</b>	Permit	Limit is 12 cases (9 liters per case max) per consumer per address per calendar year.		
<b>VIRGINIA</b>	Permit	Limit is 2 cases (9 liters per case max) per consumer per address per month.		
<b>WASHINGTON</b>	Permit	No limit.		
<b>WEST VIRGINIA</b>	Permit	Limit is 2 cases (9 liters per case max) per consumer per address per month.		
<b>WISCONSIN</b>	Permit	Limit is 12 cases per consumer per address per calendar year.		
<b>WYOMING</b>	Permit	Limit is 4 cases (36 liters max) per address per fiscal year.
